District Financials: Best Outlook in History

I recently presented to the Board of Education a \$40.4 million general fund appropriation measure representing the expected cost of general operations of the school district for this 2014-15 school year.

I reminded the audience of the 6.5 mill levy passed four years ago in August 2010 and the typical levy cycle in which the district would return to the voters every four to five years for new money. However, now four years later, discussion of the next levy is not yet showing its face on the horizon as history might have predicted would be the case.

Arriving at this point today has not come easily. Soon after the passage of the 2010 levy, the state handed down revenue reductions to local However, now four years later, discussion of the next levy is not yet showing its face on the horizon as history might have predicted would be the case.

governments, including school districts. When faced with what had been a much unexpected decrease in state funding, the school board chose to be responsive to those state revenue losses and made spending reductions to live within its means. Such reductions included the closure of two elementary schools, resulting in the reconfiguration of how grade levels are now housed across the district.

More recently, the current state biennium budget is proving to be

financially favorable to Wooster City Schools. Now in its second year, the state budget has provided additional funding to the district and has brought the continuing phase-out of tangible personal property reimbursement to a halt.

Given these events, it is very likely that a few more years will pass before the district will need to consider its next levy. I am currently updating the Five Year Forecast to estimate revenue and expenditure trends through the year 2019, as required by state law.

This document will be made available on the district's webpage after formal submission to the Ohio Department of Education on Oct. 31, 2014.

Edgewood Middle School Receives Needed Improvements

During the summer, the Wooster City School District was able to make some needed improvements to Edgewood Middle School as part of its Capital Improvement Plan.

The building had three rooms, including an old shop classroom and the LGIR, that were not being utilized efficiently. The district was able to turn these rooms into five full-functioning classrooms:

- Two tutor rooms
- One extended learning area
- Five renovated classrooms
- One computer lab

The district also updated and fully remodeled four restrooms in the building and replaced 800 lockers.




District Working to Improve Gifted and Students with Disabilities Subgroup


